

NOTICE OF PUBLIC HEARING

The Commissioners Court of Clay County, Texas will hold a public hearing to receive comments or questions of the public regarding the Proposed Annual Budget for Clay County, Texas the Fiscal Year beginning October 1, 2020 and ending September 30, 2021, on Monday, September 28, 2021 from 10:00 a.m.-10:30 a.m., in the Commissioners Courtroom located in the County Annex, 214 N. Main, Henrietta, Texas.

The proposed budget is on file in the Clay County Clerk's Office and also on the County's Website and may be viewed Monday through Friday from 8:00 a.m. to 5:00 p.m. in the office, or anytime on the County's Website.

The net taxable value of appraised property in Clay County increased from \$863,381,253 to \$876,062,140 with \$16,491,350 being New Improvements for a total increase of \$12,680,887 in Net Taxable Value in Clay County, Texas.

THE PROPOSED BUDGET WILL RAISE \$263,978.64 IN TOTAL TAXES MORE THAN LAST YEAR'S BUDGET. OF THIS AMOUNT, \$16,491,350 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR.
